Opening Keynote: ABA Resolution 606 and the Origin Story of Racism in Child Welfare Law - Prudence Beidler Carr, JD

This presentation focuses on ABA Resolution 606, which passed before the ABA House of Delegates in August 2022, to become policy of the Association. Resolution 606 calls for all legal professionals to learn about Anti-Black systemic racism within the child welfare system, stemming from the history of slavery in the United States and perpetuated by over-surveillance of and under investment in Black families in America, which is pervasive, ongoing, and a root cause of the disproportionate involvement of Black parents and children within the system. The presentation will explain why the ABA focused on examining the historical roots of racism within child welfare as a part of a legal community response to those issues.

Multiple studies have concluded that children in foster care, many of whom are victims of abuse and trauma, are prescribed psychiatric medication at a rate significantly higher than other populations of children. Much of the time, the medications are used to control behavior and anger. Many of the medications used in this population of already vulnerable children are prescribed off-label, with little proven benefit but significant risk.

There are pathways to lawful status that may be available, for example, Special Immigrant Juvenile (SIJ) status.

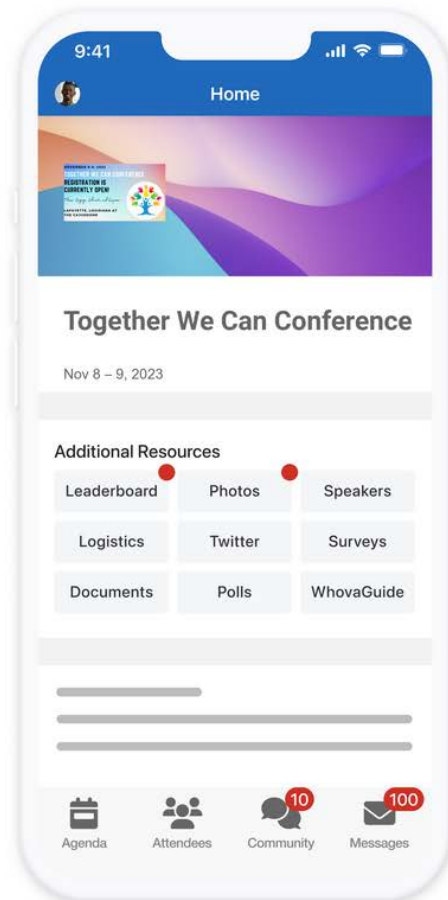
