#### Motion Hearing through Termination of Parental Rights Hearing

A motion hearing was held on June 11, 2021, and the court granted the State's request ordering that visitation be once again supervised by the agency a minimum of weekly for one hour. All other previous orders remained unchanged. As a result, the Michaels, after two months of having unsupervised visitation, once again had their visits supervised by Ms. Ross.

Due to tension between Mr. and Ms. Michaels, Mr. Michaels moved out of the home. He continued being consistent with visits and Ms. Ross noted his positive interactions with the children. Ms. Michaels' attendance at visits became increasingly inconsistent. She first started arriving at least 30 minutes late and eventually would be a no-show without communicating with Ms. Ross regarding her anticipated absence.

Ms. Shaw continued to monitor Mr. and Ms. Michaels' compliance with their substance use counseling. Mr. Michaels missed sessions but continued to submit to urinalysis, the results of which were negative for substances. Ms. Michaels remained in full relapse. During conversations with Ms. Shaw, Ms. Michaels continued to report that she was going to return to her treatment sessions, but to date has failed to resume her treatment.

Family therapist, Ms. Santosky, reports that there are varying degrees of progress between the parents. Both parents initially responded affirmatively to suggestions and acknowledged that they had made mistakes. However, recently, Ms. Michaels started exhibiting concerning behaviors and stated that she was feeling so much better that she didn't think she needed her medication any longer. Ms. Santosky is concerned that Mr. Michaels minimizes Ms. Michaels' mental health condition and is unwilling to take the situation seriously. Anthony and Ashley have been doing well with their Aunt Pauline. Anthony wants to return home because he states that he is worried about his mother and "needs to take care of her." Ashley wants to stay with her aunt.

Mr. Michaels remains a supportive presence for his children, however, he remains unable to care for his children full-time. He wants Ms. Michaels to regain custody; however, he is also fine with his children remaining with his sister until Ms. Michaels is ready. During one conversation he told Ms. Shaw, "I know Cynthia is still a mess.

Pauline is what is best for my kids. They should stay with her."

Based on the Michaels parents' lack of progress 17 months after the children were removed, the agency determined that it would be in the children's best interest to terminate their parents' rights and have Ms. Blue adopt them. Ms. Shaw had a conversation with Ms. Blue, and she stated that she is willing to be a permanent home for the children if they can't live with their parents. A Termination of Parental Rights Petition was filed on February 23, 2022, and a hearing was scheduled for May 31, 2022.

#### **TERMINATION OF PARENTAL RIGHTS (TPR) HEARING Direct and Cross Examination of Agency Caseworker Becky Ross**

Due to problematic visits and lack of parental progress to resolve issues, a Termination of Parental Rights (TPR) Petition was filed 17 months after removal of the children from their home and the hearing is being held three months after the Petition was filed.

The family had six months of supervised visitation, two months of unsupervised visits, and then due to a problematic unsupervised home visit, Becky Ross resumed supervising the visits about eight months after removal.

Assume that at the TPR hearing the agency foster care caseworker, Stephanie Shaw, has already testified to what led the agency to file the TPR petition, to the agency's reasonable efforts to reunify the family, and to the parents' failure to correct the problems that caused the children to come into care. Ms. Shaw testified that: Ms. Michaels was overwhelmed, which led to her relapse; Ms. Michaels has been unable to recover from that relapse; Ms. Michaels is no longer participating in substance use treatment; and Mr. Michaels has been minimally involved in the case and has unstable living arrangements. Ms. Shaw has also testified about the status of the children in their aunt's home, school, and community.

**State's attorney conducts direct examination**. Attempt to **introduce the visitation log as a business record** with Becky Ross to allow for testimony regarding the visits she did not personally supervise. Using the visitation log, have her testify to the facts of the case regarding supervised visitation that will support the grounds for a TPR including consistency with visits, interactions between the children and parents, and the parents' failure to improve parenting skills throughout the case.

**Mother's attorney conducts cross examination.** Try to demonstrate that most of the visits she supervised were appropriate, with the parents interacting with the children. Consider whether you will object to the admission of the business record.

**Children's attorney conducts cross examination.** Decide what position you need to go with and ask the appropriate questions. Pay close attention to the questions that have been asked so you do no duplicate. Make points with your questions. And make sure the court is aware of your position.

#### **Attorney Tips:**

- For direct:
  - Meet with the agency caseworker and review the visitation log including missed or problematic visits and review the questions you will ask to attempt to introduce this record by the witness.
  - Review any weakness in documentation and be familiar with the business practice of documentation for your agency.
  - Discuss the requirements to prove the grounds for TPR with the witness.

#### ■ For cross:

- Review the visitation supervisor's log to determine if there are any points that need to be clarified and additional information that may not have been included in the log. Be prepared to restrict/limit the use of the visitation log, including possible hearsay issues.
- Ask questions about missed visits notice to agency, canceled by others, reason for cancellation, and ability to communicate with agency caseworker about visits. Ask follow-up questions about the opportunity and efforts to reschedule visits.

#### **Termination of Parental Rights (TPR) Hearings**

#### Purpose

In a Termination of Parental Rights Hearing the primary focus is on:

- Whether a ground to terminate parental rights exists, and
- Whether termination is in the child's best interests.

The court shall enter written findings on both issues. The consideration of best interests of the child shall include consideration of the child's attachment to their current caretakerss. La. Child. Code art. 1037(B)(1).

#### Timing

The agency shall file a TPR petition if the child has been in state custody for 17 of the last 22 months, absent a documented compelling reason why filing is not in the best interest of the child. La. Child. Code art. 1004.2.

Any parent may be subject to proceedings under this title and shall have juridical capacity for such proceedings regardless of age or matrimonial status. La. Child. Code art. 1005.

Upon a showing of good cause and notice to the opposing party, the court may grant, deny, or restrict a requested continuance of the proceeding. The court shall avoid delays in resolving the status of the parent and in achieving permanency for the child. La. Child. Code art. 1032.

After final submission; the court shall render its judgment within thirty days La. Child. Code art. 1037(A).

#### Notice/Service

For the child, through counsel, and if a parent subject to a TPR petition resides within the state, service of citation shall be made through personal or domiciliary service, or by certified or electronic mail, not less than 15 days prior to commencement of the hearing on the matter. La. Child. Code arts. 1019.2 and 1021.

If the parent lives outside Louisiana, service of citation shall be made by registered mail to the address indicated in the petition, return receipt required, not less than 5 days prior to commencement of the hearing on the matter. La. Child. Code art. 1022.

A curator ad hoc shall be appointed for parents whose whereabouts are unknown and service will be made on the curator. La. Child. Code art. 1023.

If the parent has been served or has been located and notified in accordance with the rules and the parent fails to appear at the hearing, then the hearing shall be held in the parent's absence and the petitioner shall be required to establish prima facie proof of the allegations contained in the petition. La. Child Code art. 1033.

#### Standard of Proof

The petitioner bears the burden of establishing each element of a ground for termination of parental rights by clear and convincing evidence. La. Child. Code art. 1035. Although usually more than one termination ground is alleged, only one need be proven at trial.

The parent asserting a mental or physical disability as an affirmative defense to abandonment pursuant to Article 1015(4) bears the burden of proof by a preponderance of the evidence. La. Child. Code art. 1035.

#### Evidence

Author's Note to art. 1002 states "The rules of evidence applicable to civil cases apply to the proceeding to terminate parental rights." See La. Child. Code art. 105.
