Instant Safety Plan Orders (ISPOs) & Informal Adjustment Agreements (IAAs): What You Need to Know

Courtney Myers & Kayla Jones

Instant Safety Plan Orders (ISPOs) and Informal Adjustment Agreements (IAAs) offer a court process that can help minimize trauma for children and families. The ISPO is a court-ordered safety plan requested by the Department of Children and Family Services (DCFS) to manage the safety of children while custody remains with their parents. An IAA is essentially a pre-adjudication diversionary process, which may be entered regardless of whether children are in the custody of DCFS or their parents and sets forth what the parents need to do to keep the children in the home or have the children returned. These two legal arrangements can work in conjunction with one another: Sometimes a case will begin with an ISPO and then after a Petition is filed, an IAA will be entered. Come, hear from DCFS staff and an Assistant District Attorney who are utilizing ISPOs and IAAs. DCFS staff, attorneys, judges, CASAs, and foster caregivers are all welcome to attend; there will be an opportunity to learn more and ask questions.

Protective factors can serve as a helpful framework for supporting stressed and vulnerable families. Many life events bring stress and risk into a family's life. When we all work together to strengthen families by building protective factors, families are better able to create a safe and stable home that allows them to respond more effectively to issues that cause stress. This workshop will help participants better understand the importance of protective factors in building parental capacities and will offer vital resources that help service providers engage caregivers in personalized conversations about the protective factors.

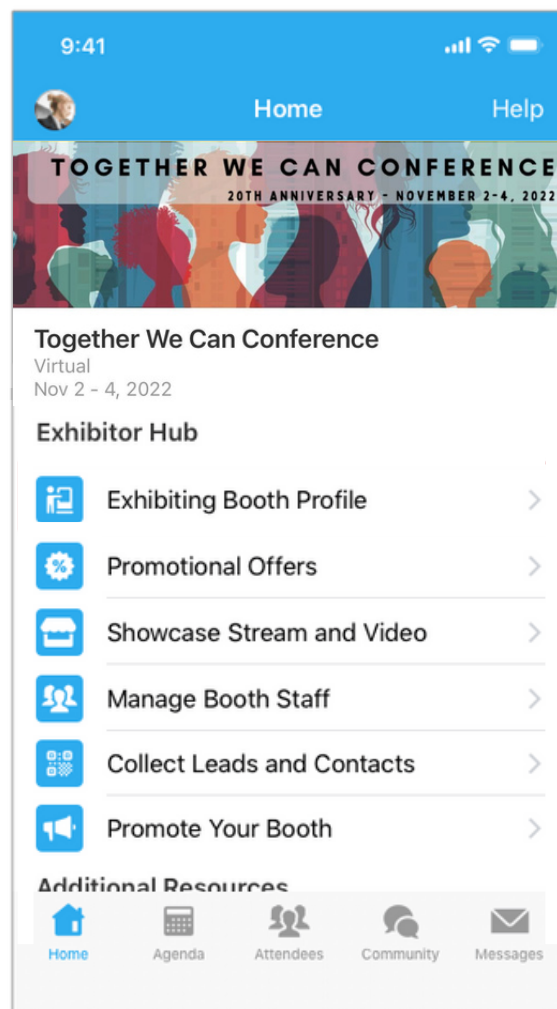
